



WORKFORCE SERVICES CONTRACT 2024-2025

THIS First Amendment is for the 2023-24 **WORKFORCE SERVICES CONTRACT** between **Big Bend Jobs & Education Council, Inc. (BBJEC) d/b/a CareerSource Capital Region (CSCR)** and **C2 Global Professional Services, Inc. (C2)**, pertaining to the contract effective July 1, 2024;

WHEREAS, **CSCR** and **C2** entered into a contract covering the period starting July 1, 2024,

AND WHEREAS, said contract is for the period July 1, 2024, through June 30, 2025,

AND WHEREAS, said contract as amended states certain amounts to be paid for services delivered under the Workforce Services Contract by **C2** through June 30, 2025.

THEREFORE, **CSCR** and **C2**, by their signature below, hereby agree with the following amendment:

Increase funding in the amount provided by **CSCR** to **C2** to deliver the following services under

- **National Emergency - North Florida Storms. \$186,000 CFDA# 17.277. FAIN: 24A60DW000035**
- **SMART Re-Entry. \$15,000 CFDA# N/A. FAIN: N/A.**
- **Wagner Peyser HOPE Florida. \$37,000 CFDA# 17.207. FAIN: 24A55WP000080**

Nature of Agreement: This document represents the agreed upon scope of work between C2 and CareerSource Capital Region.

Unless prior written approval for extenuating circumstances has been received from the Department's Contract Manager, or designee, the total Workforce Services Contract value is increased from **\$1,960,000 to \$2,198,000.**

Invoice Reporting Requirements:

- **National Emergency - North Florida Storms.** The invoice shall include costs broken out by the following cost categories:
 - Participant Wages
 - Participant Fringe Benefits
 - Participant Related Staffing Fees
 - Program Management & Oversight
 - Equipment Rentals
 - All other Costs (Indirect, Profit, Allocated Costs, Travel, etc.)
- **SMART Re-Entry:** The invoice shall include a summary of hours worked, including a description of the type of service provided (i.e., classroom instruction, individual counseling, office hours at the RISE Center, names of staff providing services, names of those receiving services, etc.)

Contract Provision Changes

Attachment D: Performance Deliverables of the Workforce Services Contract 2024-2025: Due to the September 30, 2024, change in the minimum 'Youth Average Wage at Placement' from \$12.85/hour to **\$13.00/hour**.

ITA obligations reduced from a minimum of \$850,000 not to exceed \$900,000 to **\$425,000 not to exceed \$450,000**.

ITA expenditure rate requirement reduced from 50% to **25%**.

All other provisions, except for the above changes, remain the same and are unchanged.
